## EU Trade Relations

During the last years, the European Union experienced threats to free trade due to trade conflicts creating daily news and distortions, the multilateral system of the WTO not working properly anymore and difficult Brexit negotiations. ## >> Practical and economic impacts of the coronavirus outbreak

The outbreak of the coronavirus has created a complex situation and impacted the exhibition industry heavily. Initially the main consequences were felt directly in Asia but, in the last days, more and more trade fairs in Europe are being cancelled or postponed. We will discuss about the consequences of the interruption of free travel and of global value chains; we will look at the instructions given by health authorities with the aim to ensure a safe and healthy environment for businesses to meet; and we will exchange opinions on the difficult decisions to be taken from an economic and legal point of view. How can we best handle this situation while continuing to serve our communities and industries in the best possible way and enable people to meet face-to-face? **All participants and Speakers**, *tbc*.

## Digital Europe and Cybersecurity
