ISO 20121 is a certification of sustainable management systems for all companies along the event supply chain (incl. service providers, stand designers & manufacturers).

Furthermore, it is a commitment to continuously improve towards sustainability.

How does it Work?

A Certification body will proof your management system including the management structure, documentation, evidence of the system's implementation, internal & external communication, etc.

There will be an annual review & a recertification is needed every third year.
